Ministry Application Questionnaire**

1. Your organization's name that is registered with the IRS as a non-profit organization.
2. Address of applicant's principle office.
3. Web site address for your organization.
4. Name of individual(s) responsible for submission of application.
5. E-mail addresses.

7. A copy of your organization's determination letter or other proof indicating your organization's tax-exempt status.
8. A copy of your organization's Doctrinal Statement and Articles of Faith.
9. Share evidence of a desire to establish a skateboard ministry as part of your organizations ministry outreach.
10. Share evidence of how such a ministry outreach will positively impact your area.
11. Share evidence of financial and material need within your organization.
12. Share evidence of quality leadership availability within your organization.
13. Share evidence of a plan and the ability to organize and maintain a successful skateboard ministry within your organization. Include specifics regarding where skatepark equipment will be set up and how it will be secured and how the area will be maintained so it remains a safe environment for people to enjoy their sport.
14. Share evidence that you will agree to release 2 or 3 Skateboard Ministries, Inc. from any and all liability issues that may occur as a result of receiving ministry support for a ministry involving the extreme sport of skateboarding.
15. Share evidence of how your organization plans to protect itself from being held liable for possible injuries suffered by those participating in your skateboard or skatepark outreach.
16. Share evidence, especially financial details, that your organization will take full responsibility for any and all future organizational and maintenance needs that occur as a result of establishing a skateboard or skatepark ministry.
17. Share evidence that you will and how you will uphold the good reputation and purpose of 2 or 3 Skateboard Ministries, Inc.
18. Share evidence of how you would use your skateboard ministry to support the efforts of 2 or 3 Skateboard Ministries, Inc. in benefiting other organizations in the future. Would your organization be willing to organize and host annual fundraisers to raise funds to be donated to 2 or 3 Skateboard Ministries, Inc.? Give examples of possible types of fundraisers your organization would have.

23. Share any final comments that you think would be helpful for us in determining whether to support your ministry.

Provide a signature, printed name and dates from the one preparing this application along with the signatures, printed names and dates from two witnesses who will declare that, to the best of their knowledge and belief, the information included in or attached to this application is true and correct.
